## Directions to Our Office

### Coming From The North

If you are coming from the North, take 75/85 South to downtown.

Exit Courtland St. (Exit 249A)

Continue on Courtland until you come to Andrew Young International Blvd. (third light). Turn right onto Andrew Young International Blvd.

After turning right onto Andrew Young International Blvd, the first light you see will be Peachtree Center Avenue. Cross over Peachtree Center Avenue, and enter International Parking garage immediately past a Chinese restaurant (HSU's) on the left.

After walking out of the garage, walk across the street and into Peachtree Center Mall, and go up 1 flight of the escalator. Turn to your left and walk out of the building and enter the North Tower (located in front of you - towards your right). While the signs are not large - each tower has the name listed on the front of the building. (Each tower has a guard stationed at the front desk.) Once inside the building, you will see elevators on either side of the lobby. Take an elevator that will allow you to get to the 15th floor. Our office will be on your left as you exit the elevator.

### Coming From The South

If you are coming from the South, take 75/85 North to downtown.

Exit Andrew Young International Blvd. (Exit 248C), and turn left at the second light off the exit onto Andrew Young International Blvd.

Once on Andrew Young International Blvd, go to the third traffic light and cross over Peachtree Center Avenue, and enter International Parking garage immediately past a Chinese restaurant (HSU's) on the left.

I-20 Eastbound to I 75/85 North, towards downtown.

### MARTA

We are also easily accessible by MARTA . Take MARTA TO Peachtree Center Station (stop #N1). Once you exit the train, follow signs to Harris Street and the food court. (If you are traveling north you will go to the right. If you traveling south you will go to the left.) Take the escalator or elevator to the street level on Peachtree Street. Look to your left, and you should see a Brooks Brothers store. We are in the North Tower (the entrance to the building is just behind the Brooks Brothers store). Take an elevator that will allow you to get to the 15th floor. Our office will be on your left as you exit the elevator.
